1. Public Comment

2. Welcome, Introductions and Purpose of the Task Force

Each attendee introduced themselves.

The purpose of the Task Force is to attract and retain small businesses in Beverly Hills and to continue to ensure that Beverly Hills provides a favorable business climate for small business.

3. Presentation on Proposed Changes in Water Rates

Gilbert Borboa from the City of Beverly Hills provided a brief overview of proposed changes in water rates in the City for businesses. Overall, water charges for businesses should remain essentially unchanged or have a slight decrease.

4. Recap of Last Meeting

Todd Johnson provided a brief recap of the last meeting which identified several potential focus areas for the task force.

5. Potential Focus Areas

The group discussed specific challenges for small businesses including creating more foot traffic, specific measures to improve foot traffic, steps to beautify specific streets aside from Rodeo Drive, and opportunities for innovative parking solutions. Also discussed was the idea of creating a master plan for neighborhoods or the City as a whole to make sure actions taken are cohesive.

6. Discussion with Landlords and Brokers

Houman Mahboubi, Carine Mamann, Mark Tronstein and David Mirharooni appeared as guests at the meeting to provide their perspective on the market and ways to help with small business. Amongst other items discussed were ways to attract a younger demographic to Beverly Hills and how to stay ahead of competition from neighboring commercial areas.
