1) Review of Foundation Donations Received to Date

Chief Financial Officer Don Rhoads provided an overview of all donations received to date (\$258,890 total) since the last CBHCCF Board meeting in October 2013. Staff received direction to provide a comprehensive master report of donations in addition to a detailed report (i.e. include pledges, aggregate amounts per donor, total donations to date, etc.). Board provided direction to approve and accept the \$258,890 in donations received since the last meeting.

2) Community Charitable Foundation Fund/Account Requests

a) Staff member Hunt-Coffey presented information regarding a collaborative project (City's Human Relations Commission; Beverly Hills Public Library; Friends of the Library; and Beverly Hills Unified School District [BHUSD]) titled the "One Book One City" Program which provides books to BHUSD students and will culminate in an author event on October 12, 2014. (The book that was selected is *The Boys in the Boat* by Daniel James Brown.) Ms. Hunt-Coffey reported that a \$5,000 donation was recently received for the purchase of 500 books and requested that the Foundation create an account to receive this and future donations. Staff will provide a report to the City Council about the program and donation, and seek an appropriation of the funds to the Library's book account in order to purchase the books.

Approved the creation of a "One Book One City" donation account; and approved and accepted the \$5,000 donation.

b) Staff member Hunt-Coffey presented information regarding the City's "After School Scholarship Program" which provides financial assistance to low income Beverly Hills families who wish to participate in the Recreation Division's programs and classes. Ms. Hunt-Coffey also provided clarification that the City (not the Foundation) will have the responsibility to determine criteria for qualifying families, scholarship limits per family, and disbursement of funds.
