### 1) CBHCCF Foundation Donations Update

Chief Financial Officer Rhoads provided an overview of all donations received to date totaling \$1.8 million including those approved since the November 17, 2014 Board Meeting (\$723,375). Community Services Administrator Grable reviewed current donation pledges to date for the Beverly Gardens Park fundraising efforts.

## 2) Expense Report of CBHCCF Donations

Chief Financial Officer Rhoads reported expenses to date for Fiscal Year 2015 totaling \$619,371 for the following projects: Beverly Hills Police Memorial Project; One Book One City program; and the Beverly Gardens Park Project.

## 3) Sample "Charitable Pledge Agreement"

Community Services Administrator Grable and Chief Assistant City Attorney Enriquez presented a sample Charitable Pledge Agreement for discussion. It was suggested that a simpler "pledge card" be utilized for smaller donations; that the template and/or letter be customized depending on the donation type and timeframe; and that a provision be added in reference to the donor's heirs and the donor's original donation pledge.

4) City of Beverly Hills Community Charitable Foundation Website at www.beverlyhills.org/gifting or www.beverlyhills.org/donations

Management Analyst Harris presented an overview of the Foundation's website. It was suggested that the City create an on-line interactive donation form. Staff will work with Finance and the Information Technology Departments in order to assist with the creation of such a form.

Staff received direction to remove specific donation amounts by specific donors from the website, and provide categories of donations instead of specific details (for example only: \$5,000 and below; \$5,001-\$49,999; \$50,000-\$99,999; and \$100,000 and above) with donors listed alphabetically.

The Board also requested that staff remove Schedule B contained within the copy of the Form 990 (on the CBHCCF website) since it includes donor names and information.

# 5) Support to Friends of Beverly Gardens Park Fundraising Efforts and/or Other Funding Generation Opportunities

Staff provided general information regarding the City's "Friends Of" groups (Beverly Gardens Park; Greystone; Beverly Hills Public Library; etc.) in case any CBHCCF Boardmembers wish to assist with community fundraising efforts.
